have been set to explore and discuss these findings. First draft of the report will be ready by end of September and full report will be published by Lancet Psychiatry early next year. 2016-2017 is the year of WPA campaigning for Social Justice for persons with mental illness. We are developing Bill of Rights for Children and young people and on Rights of those with intellectual disability.

Several Position Statements have been launched including the mental health of migrants, refugees and asylum seekers; LGBT individuals and reasons to be a psychiatrist. World Psychiatry in the very near future will be bringing these out, please look out for them.

The work on setting up **Diploma in Psychological Medicine** aimed at psychiatrists continues apace and we hope to launch it next year.

We are still looking for examples of good clinical practice so that we can learn from each other. Please keep them coming.

WPA has an International Congress in Cape Town from 18-22 November. Please put the dates in your diary. This will be an exciting conference with eminent speakers and range of symposia and workshops. I look forward to seeing you at the conference and hearing your thoughts.

## ■ NOMINATIONS FOR THE WPA JEAN DELAY PRIZE 2017 ARE WELCOME



Jean Delay

Jean Delay Prize is the most prestigious award that WPA gives triennially. This is awarded to an individual who has made a major contribution in the biological, psychological or social aspects of Psychiatry or has built useful bridges between them. An international jury selects the awardee.

The Prize bears the name of the first President of the WPA, who made significant contributions to the practice of psychiatry in the 20th century.

It consists of a certificate, a medal and a cheque for the amount of 40,000 Euros. The awardee will be expected to deliver a plenary lecture at the next World Congress of Psychiatry in Berlin in October 2017.

The deadline for the submission of nominations is December 31, 2016 and the "Jean Delay Prize 2017 Nomination Form" could be downloaded from the WPA website ([www.wpanet.org](http://www.wpanet.org)).

The Selection Criteria of the applicants are as follows:

1. Staff of pharmaceutical companies are not eligible for the Prize.
2. Members of WPA Council, Executive Committee and Jury of Jean Delay Prize are not eligible for the Prize.
3. In case the awarded work is a specific project, it shall not be related to a pharmaceutical product.
4. There shall be no conflict of interest between SERVIER and the Prize-winner.
5. A full disclosure will be requested of every applicant, giving details of any significant financial interest relating to the projects proposed for the Prize.

## ■ GENEVA PRIZE FOR HUMAN RIGHTS IN PSYCHIATRY 2017

The Geneva Prize for Human Rights in Psychiatry will be awarded for the 7th time in October 2017 during the World Congress of Psychiatry in Berlin, Germany. The Geneva Prize represents a

unique opportunity to honour a colleague, an individual, an institution or association, for their exceptional dedication and work towards Human Rights in Psychiatry. The Geneva Prize includes a certificate, a medal and a cheque for 20,000 Swiss Francs.

I am so excited and honored to report on behalf of the Operational Committee of the WPA Scientific Publications. This has been a very busy and productive time for our group. We have been holding several telephone meetings to help develop projects and programs that will help support the work of WPA members, especially from low-resourced countries. We have talented, experienced members of our Committee who themselves are editors of prestigious journals and who want to help make available not only existing journals and exemplar papers, but who want to help provide educational experiences for young psychiatrists on how to learn to get their work published.

The members of our Committee are: Michelle Riba - Chair † Dusica Lecic Tosevski - Co-chair † Reinhard Heun † Peter Tyrer † Christopher Szabo † Alfredo Cía † Prabha Chandra † Joao Mauricio Castaldelli-Maia.

Prof. Heun sent out a letter to Presidents of the WPA Member Societies, letting them know of our desire to include various open access journals to the WPA website, under scientific publications. This would be a way to provide free learning resources for researchers and clinical psychiatrists worldwide. We asked our Presidents to propose national journals that would be perceived as relevant for this WPA website, as well as to obtain any necessary permissions. We have appreciated the wonderful support and help from our

WPA Secretary General Roy Kallivayalil and the WPA Executive Committee for their advice and support of this effort. We have received such enthusiastic response from so many Presidents. Prof. Prabha Chandra has so graciously offered the help of an excellent research assistant who will help in collating and organizing the material. Please let us know if you have suggestions, ideas or relevant journals that can be uploaded to this site. You can contact me at [mriba@umich.edu](mailto:mriba@umich.edu) or Professor Heun.

At the upcoming WPA meeting in Cape Town, South Africa, under the leadership of Professor Christopher Szabo, and with input from Professor Castaldelli-Maia, we plan on holding a workshop to help junior psychiatrists learn about publishing and to be able to ask questions and answers from experienced and world-renowned editors of psychiatric journals. This follows other workshops we have held at other WPA meetings. We plan to upload some of these presentations on the WPA website under scientific publications so that those who are not able to be in attendance can benefit from the presentations.

We are very appreciative of the work of our highly respected Professor Alfredo Cía, who with his passion and commitment has set up a WPA supported resource library for scientific publications, in Spanish. We look forward to learning how this library is used and how such libraries can evolve in other parts of the world.

In addition, over the last several months, several of our WPA colleagues have asked for the WPA logo to be used for new books that will be published. We have a process for this review and for providing the WPA logo. If you are planning on publishing a book that you think would benefit from having the WPA logo, please let me know so that I can send you the documents that will be reviewed prior to the release of the logo.

## From the WPA Secretary for Education



Edgard Belfort

We are pleased to inform you that continuing **WPA Recommendations: Principles and Priorities on a Training Curriculum for Psychiatrists**, the Task Force Members met on June, 21st and 22nd 2016 in Madrid, Spain and reviewed the project of the Core Curriculum in Psychiatry. The meeting was very fruitful. The purpose of this project would be to write a set of:

1) WPA Educational Perspective: Define the role and profile of psychiatrists at present and in the coming years.

2) Training Curriculum: The Curriculum should be a practical educational document based on three competencies: a) Knowledge: like psychopathology, pharmacological and psychotherapeutic aspects, the promotion of mental health, transcultural, ethical and legal aspects, evidence and values based medicine. b) Skills: Doctor-patient relationship, clinical-case formulation, Psychiatrists skills to achieve to become trainers of trainers Present (teach to teach), paying special attention on scientific research. c) Abilities: every psychiatrist should possess in order to carry out his/her profession based on ethical and scientific values.

3) The program should be evaluated on its competencies, identifying the minimum number of months needed to acquire training, number of trainees, minimum requirements, programs accreditation or identifying subspecialties.

4) Recommendations: It was suggested that because of the social and economic diversity of the different member countries of the WPA, a good idea would perhaps be to make

minimum recommendations that can be met by all countries according to their income level and other requirements that suit those countries with more resources as contained in the WHO Mental Health Report N°. 2012.

We are inviting feedback on the above aspects before September 30th, 2016, with the aim to prepare a summary for the next meeting which is scheduled to take place at the Congress of Cape Town, 18-22 November 2016. My thankfulness to the Task Force, formed by the colleagues: Chair Dinesh Bhugra, Co-chair Edgard Belfort, Coordinator Maria-Ines Lopez-Ibor. Members: Julio Bobes, Michel Botbol, Miguel Casas, Maria-Luz Casimiro-Querubin, Francisco Collazos, Javier Correas, Bulent Coskun, Fabrizio Delgado, Andrea Fiorillo, Silvia Gaviria, Marc Hermans, Roger Ng, Felipe Picon, Javier Quintero, Pedro Ruiz, Constantin Soldatos. Consultants: Murthy Srinivasa, Donna Stewart.

Another important subject is the Model Curriculum for Primary Care Physicians, on which a group is already working. The primary care physician is the first to see patients with either primary psychiatric illness or general medical and psychiatric comorbidity 70% of the time. We have sent USB keys with the entire curriculum on Neuro psychopharmacology developed by the American Society of Clinical Psychopharmacology (ASCP). WPA is making available free USB keys to selected number of institutions in the low and middle income countries (dispatched to 43 member societies) for teaching purposes.



## BILL OF RIGHTS FOR PERSONS WITH MENTAL ILLNESS

The World Psychiatric Association (WPA), a global organization representing nearly 250 000 psychiatrists, urges ALL Governments to ensure that persons with mental illness/mental disability/mental health problems are not discriminated against based on their mental health status, and are treated as full citizens enjoying all rights on an equal basis with other citizens.

The WPA supports the efforts of the international community as expressed through various international human rights Covenants and Conventions, and, more particularly, the United Nations Convention on the Rights of Persons with Disabilities (CRPD). The WPA reiterates that persons with mental illness/mental disability/ mental health problems have the capacity to hold rights and exercise their rights and should, therefore, be treated on an equal basis with other citizens. This includes, but is not limited to:

1. Right to **accessible** and **affordable** mental and physical healthcare;
2. Right to live **independently** in the community as other citizens;
3. Right to **work** and **opportunities** to work and **protections** at work, including **affirmative action**, as available to other citizens;
4. Right to **adequate** income to meet their basic needs for food, housing, clothing and other basic necessities;
5. Right to **accessible, integrated, affordable** housing;
6. Right to **training** and **education** as available to other citizens;
7. Right to **freedom of movement** and **removal** of restrictions on free travel.
8. Right to **own, inherit, and dispose** of property, and to be provided **adequate support** to exercise this right;
9. Right to **marry, have** and **adopt** children, and **raise** families, with additional support when required;
10. Right to **determine** their future and make their **own life choices**;
11. Right to **vote** and be **elected** to public office;
12. Right to be recognized as **equal** before the law as other citizens, and the right to **full protection** of the law;
13. Right to be **free** from **cruel, inhuman, degrading treatment, and punishment**;
14. Right to **confidentiality** and **privacy**; and
15. Right to **participate** in the **cultural** and **social life** of the community and **practise a religion** of their choice.

2. Psychological distress among medical students in conflicts

Plus some papers from our colleagues outside the country: Advances in understanding the etiology of schizophrenia.



Syrian Arab Association of Psychiatrists is also starting an Authoring Systematic Reviews Course (Cochrane) practical in cooperation with a group of Cochrane authors in Syria starting on 8th August 2016 in Damascus.

Horizontally and to fill the shortage in the number of psychiatrists in Syrian, Syrian psychiatrists working with WHO trained about 1,000 Doctors from different specialties of primary health care on the WHO/MHGAP program.

Syrian Arab Association of Psychiatrists attended all MHPSS programs sponsored by the UN, INGO, LINGO, and governmental association in training and practicing.

Its Executive Committee Founding Partners are: Prof. Armen Soghoyan (President, Armenian Psychiatric Association and WPA Secretary of Finances),

Prof. Fuad Ismayilov (President, Azerbaijan Psychiatric Association), Prof. Eka Chkonia (President, Society of Georgian Psychiatrists); Chair/Coordinator is Prof. Uriel Halbreich (Chair, WPA Section on Interdisciplinary Collaboration). ## ■ ZONE 14 (EASTERN AND SOUTHERN AFRICA)

Impact of Socio Economic Inclusion Programs for People With Mental Health Issues in Kenya: Socio economic marginalization for people with mental health issues in Kenya continues to be a major barrier towards recovery; however, various organizations, including the government, have made several strides towards improving this situation. Through the Persons with Disabilities Act, the government has provided incentives such as tax deductions for employers who provide reasonable accommodation to people with disabilities and income tax exemption to employees with mental health issues.

Africa Mental Health Foundation, in partnership with various international organizations and learning institutions, continues to advocate for socio economic inclusion for people living with mental health issues through several social business models. The recently concluded CREATE and LIPTK projects advocate for creation of opportunities for real work for people living with mental issues to promote recovery and wellness in urban informal settlements and rural Kenya.

Individuals, family members, and the community have reported positive impact re-

sulting from these initiatives. Reduction of stigma both self and social, awareness of local mental health services and mental health recovery, improved livelihoods and a general shift in mind set have been observed from the data collected.


